# GRAY WATER DISTRICT TRUSTEES MEETING May 16, 2022

Location: 80 Shaker Rd

Present: Bruce Sawyer, Steve Dunn, Mike MacDonald, Mitch Berkowitz, Joe Murray and Superintendent Bill Gardner. Bruce called meeting to order at 6:00 PM.

# **Superintendent's Report:**

- 1. Average gallons per day (AGD) for pumps 1&2 was 286,733. Pump 3 was run for 5 days for an average of 109,284.
- 2. Water tests in April were absent of bacteria.
- 3. The water service for Portland Sand & Gravel has been completed.
- 4. We are working with Merrill Excavation on a list of service repair that has been building for the past few years. We will be doing more this Thursday.
- 5. Seasonal installs have begun.
- 6. We are working toward getting five unmetered residential accounts outfitted with proper meter settings.
- 7. A new lawnmower has been purchased to cut grass at our 80 Shaker Rd, 41 Yarmouth Rd and 299 Yarmouth Rd locations.
- 8. There is a new service going in on Colley Hill Rd. A rough measurement shows it is close to 200' which is when we usually require a meter pit. Meter pits are not available right now due to supply chain issues. The service will be installed as usual and a meter installed inside the building.
- 9. We are still waiting on parts for the cemetery meter pit repair.
- 10. We have been marking ahead of the survey work being done for the West Gray Rd project.
- 11. We heard back on the fencing grants we applied for. We were awarded \$12,500 for fencing at Pump Station 3 and \$20,000 for fencing at 80 Shaker Rd. The fencing job at Pump Station 3 is on the schedule with Gorham Fence. Fencing at 80 Shaker Rd will be impacted by the work for the turnpike crossing project so we'll need to hold off and do it in conjunction with that project.

### **OLD BUSINESS:**

#### **Landfill Test Well Results:**

Trustees and Bill discussed the response that was received from Town Manager Nate Rudy. In his email response Mr. Rudy attached a report from Woodard & Curran and stated that it addresses our concerns. Neither the report nor Mr. Rudy has addressed concerns we have been writing to them about for the past few years. Steve is to draft another letter to the Town that will hopefully be clearer as to the specific issues that need to be addressed. **ACTION:** Steve to write another letter.

### **NOAA Request for Service/GWD Charter Amendment:**

This project is ongoing. Bill reported to Trustees that a customer over on Depot Rd noticed the markings on the road and requested a service hookup. We will have to investigate if that is possible.

**ACTION:** Bill to investigate as the project goes on.
